



The McKesson Pharmacy Scholarship Program

THE PROGRAM

The McKesson Pharmacy Scholarship Program is independently administered by Scholarship America, a national nonprofit student aid service organization. Recipients are selected without regard to race, color, creed, religion, age, gender, disability, or national origin.

ELIGIBILITY

Applicants to the McKesson Pharmacy Scholarship Program must be:

- Children or grandchildren of a drugstore owner or pharmacist who is a McKesson pharmacy customer.
- OR
- Pharmacy students employed by a drugstore owner or pharmacist who is a McKesson pharmacy customer. Each McKesson pharmacy customer may sponsor the applications of up to two pharmacy student employees.

All applicants must currently be enrolled in or have been accepted to an accredited School of Pharmacy and be in their 3rd, 4th, 5th, or 6th year of collegiate study. Pre-pharmacy students are not eligible.

AWARDS

Up to fifty \$1,000 awards will be granted for one year of full-time study.

Awards may be renewed for an additional three years. Renewal is contingent upon satisfactory academic progress, continued study in pharmacy, and the recipient not being subject to any disciplinary action.

APPLICATION

The application is available online from July 1 through October 31, 2009. Applicants must submit the electronic application and must also mail required documents no later than the application deadline.

SELECTION OF RECIPIENTS

Scholarship recipients are selected on the basis of academic record, demonstrated leadership and participation in school and community activities, honors, work experience, statement of goals and aspirations, unusual personal or family circumstances, and an outside appraisal. Selection of recipients is made by Scholarship America. In no instance does any McKesson officer, employee or customer play a part in the selection.

All applicants will be notified by mid-December. Not all applicants to the program will be selected as recipients.

PAYMENT OF SCHOLARSHIPS

Scholarship America processes McKesson Pharmacy Scholarship payments on behalf of McKesson Foundation. On or about December 30, Scholarship America will mail the full scholarship award to each recipient's home address. Checks will be made payable to the school for the student.

OBLIGATIONS

Recipients have no obligation to McKesson. They are, however, required to supply Scholarship America with current complete transcripts and to notify Scholarship America of any changes of address, school enrollment, or other relevant information.

REVISIONS

The McKesson Foundation reserves the right to review the conditions and procedures of this scholarship program and to make changes at any time including termination of the scholarship program.
